## Long - Awaited Changes to SBA Certification Application Process

A new, improved SBA certification platform is on the way! The new website will streamline the application process by allowing entities to submit one application for all certifications, eliminating the need to perform duplicate tasks when applying for multiple certifications and providing a more efficient process. The new, user-friendly interface will also aid in expediting all applications. Effective August 1, 2024, no new applications are being accepted for 8(a), WOSB/EDWOSB, VOSB/SDVOSB, and HUBZone certifications. The upgraded system is anticipated to launch in September 2024 at which point SBA will resume accepting renewals and applications. Applications already submitted before the August 1 cutoff will be processed in the order in which they were received. Firms facing a critical contracting deadline can contact <u>certifications@sba.gov</u> or 202-205-6459. Please provide the proposal number, agency, and bid due date.

## Small Business? There's an Office for That.

In government contracting there are resources available to help small businesses succeed. Federal Small **Business Offices and** Prime Contractor Small **Business Liaison Offices** can help you understand the needs and preferences of a particular agency or

prime contractor. They can also put you in contact with decision makers or project managers to determine if help with similar things your company is a good fit. Small Business Offices within government agencies can help you gain insight into a solicitation and advocate on your behalf for set-

asides. Likewise, most large prime contractors have a Small Business Liaison Office that can when you hope to subcontract or become their vendor. They are often found on the agency or Prime's website or by connecting with them via platforms like LinkedIn.

Why Comply With FOCI (Foreign Ownership, Control or Influence)?

According to the U.S. Counterintelligence and Security Agency, "Foreign investment can play an important role in maintaining the vitality of the U.S. industrial base. Therefore, it is the policy of the U.S. Government to allow foreign investment consistent with the national security interests of the United States." Foreign Ownership, Control, or Influence (FOCI) procedures are intended to mitigate the risks associated with FOCI by ensuring that foreign firms cannot undermine U.S. national security by gaining unauthorized access to classified information through their affiliation, direct or indirect power, or ownership interest in a US company.

Your GACO APEX Accelerator is tasked by the DoD Office of Small Business Programs (OSBP) to increase businesses' awareness of and compliance with FOCI through counseling and training options from Govology and Project Spectrum.
